

## GRINDER PUMP USER AGREEMENT

This Grinder Pump User Agreement is made and entered into by and between the Morehead Utility Plant Board, an agency of the City of Morehead, Kentucky (hereinafter referred to as "MUPB") and the undersigned person or persons (hereinafter referred to collectively or individually as "Owner"):

MUPB and Owner hereby mutually agree as follows:

1. For and in consideration of a one-time grinder pump sewer tap fee, the receipt by MUPB is hereby acknowledged, MUPB shall purchase and install upon the premises of Owner an individual sewer grinder pump and which shall be tapped into MUPB's sewer collection system.

2. Owner shall be responsible for extending all plumbing and electrical connections from Owner's residence or other structure to be served to the grinder pump and insuring said connections are made in accordance with all applicable laws, regulations and codes.

3. MUPB shall retain sole and exclusive ownership of the grinder pump following installation and shall be responsible for maintenance thereof.

4. Owner shall not permit any tampering with the grinder pump or its components, i.e. electrical controls or plumbing connections. Owner shall not permit discharge into the sewer glass, metal, plastic, wipes (baby, shop or adult), needles, sanitary napkins, tampons, shells, diapers, disposable cleaning products, oil or grease, explosives, flammable materials or any other substance or object that cannot reasonably be expected to be processed and conveyed by the MUPB grinder pump. Owner further agrees that in the event of grinder pump malfunction or if the grinder pump warning light comes on to notify MUPB immediately.

5. Owner agrees not to obstruct access to the grinder pump in any way that would impede MUPB from maintenance, testing or replacing said pump. Such prohibited obstacles include but are not limited to shrubs, flowers, fences, doghouses, etc.

6. Owner agrees to indemnify and save MUPB harmless from all claims, loss, costs and expense, including attorneys fees, by reason of injury to any person or property on or about the premises, which injury results or in any way arises out of the location, use, maintenance or operation of the grinder pump or any appurtenances thereto, but for the direct negligence of MUPB.

7. Owner acknowledges that in addition to the one time tap fee, Owner will be responsible for payment of sewer user rates and fees and electricity supplied to the grinder pump.

8. Owner acknowledges and agrees that in addition to this Grinder Pump User Agreement that as a MUPB sewer utility customer that Owner is subject to and will comply with any ordinances, regulations or policies of MUPB relating to grinder pumps, sewer usage, rates, billing, payment, and nonpayment, now in place or hereinafter enacted.
